The New York State Local Government Efficiency Program

Abstract

The New York State Department of State implemented a new local government efficiency program in 2005. Hundreds of local governments have been awarded grants to improve their operations. The New York State Department of State maintains a data system which show that 294 local government improvement projects are expected to generate \$418 million in cost savings associated with program costs of \$46 million. This results in a benefit cost ratio of approximately 9.1 times. The Department of State also maintains a system of project documents for a number of local government improvement efforts. These documents can be reviewed by other local government officials who are considering making changes to their organization. The Department of State grant program is also innovative because in 2016 it introduced a system of competitive grants for certain projects. A program manual exists and is entitled *Competition Guidelines Municipal Consolidation and Efficiency Competition*. This grant program analyzes local government proposed cost savings efforts to ensure that the most cost effective grants are favored over less efficient grants. This paper outlines the system in simple to understand terms and contains a number of appendices that can be used by local officials to understand the issues associated with local government improvement efforts.

Introduction

The State of New York New York Executive Budget for 2005-2006 established a Local Government Efficiency Program (Efficiency Program) which is designed to make local governments more efficient.¹ The program is administered by the New York State Department of State (Department of State). The Department of State claims that the program has generated 294 individual projects with \$46 million of new investments and \$418 million in cost savings. This amounts to a benefit cost ratio of 9.1 times.

The Efficiency Program has seven specific program areas. These include:

- 1. **General Government**. This applies to local government planning issues, building codes, court systems, and parks and recreation.
- 2. **Government Reorganization**. Consolidation of local government agencies are examined under this program.

- 3. **City and County Charter Revision**. This program has a focus on basic government forms and charter revisions.
- 4. **Education**. School districts, libraries, and Boards of Cooperative Education (BOCES) are the focus of this program.
- 5. **Municipal Utilities**. This part of the program has a focus on drinking water systems, storm water utilities, waste water facilities, and electricity and natural gas systems.
- 6. **Public Safety**. Police and fire and public health issues for local governments are evaluated under this program.
- 7. **Transportation**. This applies to local government highway issues, public works, and mass transit.

The Department of State provides grant programs, training and other activities to assist local governments. Two types of grant programs are involved. There is a Local Government Efficiency Grant Program and The Local Government Citizens Reorganization Empowerment Grant Program. The Department of State is also a part of the New York State Financial Restructuring Board for Local Governments (Albany Research in Public Administration Report #2016-2). The Department of State can offer its expertise in that program which also develops improvement programs for local governments.

Department of State Local Government Efficiency Grant (LGe) Projects

The Department of State maintains a list of grant funded projects on its webpage.² The list current contains 436 projects with a value of approximately \$81 million. The average value for the projects is about \$186,000. There are 30 projects with values of \$500,000 or greater as shown in Appendix 1. Many of the larger projects are associated with water and sewer facilities. Examples of other projects are for shared services agreements, government reorganization studies, dispatch systems, police improvements, school systems

improvements, senior citizen resource programs, and economic resources programs. Local governments can apply for the grant programs using the guidelines outlined on the Department of State website.

Grant Funding Proposals and Benefit Cost Analysis

The Department of State has a formal grant application for localities to use when submitting a proposal for funding. Appendix 2 shows the basic documents used in a grant proposal. The Department of State claims that the program has generated 294 individual projects with \$46 million of new investments and an estimated \$418 million in cost savings. This amounts to a benefit cost ratio of 9.1 times. Benefit cost analysis has been used for many years to analyze government programs. (Boardman et al. (2006), Finkler et al., (2017), Gramlich (1981), Sassone and Shafer (1978). The local governments participating in the program are required to submit a form showing the projected benefits and costs from individual projects. Appendix 3 contains an example of the financial form used. The Department of State aggregates the amounts shown in these forms to develop the benefit cost ratio of 9.1 times.

Appendix 4 shows the format of work plans that are developed for individual projects. The illustration in Appendix 4 is for one portion or component of a larger work plan. Complicated work plans will have many individual components. There is also an implementation period for the grant funded projects and this can last for many months or years depending on the complexity of the project. For instance, a complex water or sewer project may entail years of environmental reviews, engineering studies, and actual construction.

Competition in the Grant Process

One of the innovative features of the Department of State's grant funding is the use of competition in the grant process. During 2016 the Department implemented a Municipal Restructuring Fund. A program manual exists and is entitled *Competition Guidelines Municipal Consolidation and Efficiency Competition* (New York State Department of State (2016). A review of the application includes a competition review to ensure that the most cost effective grants are favored over less efficient grants. A scoring mechanism is used to rank the grants

and the more competitive grants are selected over less competitive grants. A system of non-competitive grants also exists for certain government consolidation proposals such as shared services agreements.

LGe Studies and Reports

Another feature of the Department of State's Local Government Efficiency program includes the numerous studies and reports maintained on the department's web site. Appendix 5 shows a matrix of information that is maintained by the Department of State on its web site. Governments interested in reviewing reports and other information in the seven program areas can simply click on the matrix to find detailed information about what other local governments are doing to improve operations. Previous consulting studies and other reports are available for local government officials to review. Many of these reports illustrate the types of issues and problems that should be addressed when localities are considering changing operations. Reports exist in the following areas:

- 1. General Government (20)
- 2. Government Reorganization (22)
- 3. City and County Charter Revision (4)
- 4. Education (17)
- 5. Municipal Utilities (7)
- 6. Public Safety (21)
- 7. Transportation (13)

Local governments can benefit by reviewing the reports to study that types of issues they may face as they undertake reorganization and other cost improvement efforts. The reports can be viewed at wenhttps://www.dos.ny.gov/lg/lge/Case_Studies.html.

Appendix 6 shows information pertaining to the reorganization of public safety efforts for local governments. For example, two fire districts



located near Albany, New York including the Defreestville Fire Protection District and the North Greenbush Fire District #1 consolidated into a single town-wide fire district. Local government officials can review the information found in Appendix 6 and review detailed information and reports on other public safety reorganization efforts for localities in New York State. Many types of other transactions such as efforts to improve municipal utility systems or basic government reorganization plans can be reviewed by using the matrix maintained by the Department of State.

Appendix 6 Public Safety Consolidations

In New York State, municipalities has varying levels of public safety services.

Communities considering improving efficiencies or making sustainable cost reductions in the area of public safety may be eligible for a Local Government Efficiency grant to assist with studying the feasibility of different options or to assist with implementation of a strategy.

Example: The Defreestville Fire Protection District and the North Greenbush Fire District #1 consolidated into a single town-wide fire district. The consolidation study and implementation plan were funded from the 2006 SMSI grant program.
